Has obtained EC TYPE EXAMINATION INSPECTION CERTIFICATION, in compliance with what is stated in Directive 89/686/EEC and in agreement with the applicable test procedures according to standards *EN ISO 13688:2013* General requirements and *EN 469:2005/A1:2006* against risks in the operation of firefighting and related activities (Xf2, Xr2, Y2, Z2), having attained the levels of provision specified in TEST TECHNICAL REPORT N°2015EP2935CE and in PPE'S TECHNICAL DOCUMENTATION.

PPE DESCRIPTION:

JACKET: A garment comprising front and rear pieces, sleeves and a collar, in navy blue woven fabric and lined in grey fleece. The two front pieces close down the centre with a black plastic zip with black metal pull running from the bottom hem to the top of the collar and covered by a 10 cm-wide exterior flap from the hem to the collar. The flap is sewn to the left-hand side and fastens across the right with a strip of selffastening tape. Each front piece is made from a single piece of fabric joined to the back with a single seam. Small, 1 cm-wide 6 cm-long loops are attached either side at the breast: the right-hand breast has an additional two larger loops, one of which folds back on itself. Attached to these additional loops with self-fastening tape is a metal attachment joined to the lower loop. The left-hand breast has an expanding pocket open at the bottom and closed with a flap fastened with self-fastening tape. A pocket with angled opening is attached either side at the waist, the opening is covered by a 7 cm-wide flap with stitched hem, fastened with a piece of self-fastening tape on one corner. The shoulders are reinforced in black fabric. Inside is an open pocket on the left-hand side with a vertical opening, parallel to the central zip and another pocket at breast height which closes with self-fastening tape. At the bottom is an 8 cm-wide strip of black laminated fabric. The back is made from a piece of fabric with pleats either side. At the top is a small 6 cm-long 1 cm-wide loop sewn to the outer face of the collar. A garment size label is attached at the collar seam and two garment conformity labels are attached to the inner face of the back. The sleeves are made from three pieces of fabric joined by vertical seams from the arm hole to the cuff. The cuff is made from a folded piece of navy blue fabric with a thumb hole and laminated black fabric on the inner face. The elbows are reinforced with two pieces of fabric which have two pieces of reflective material in yellow-grey-yellow running around the sleeve.

The collar is rectangular and either side of the central zip is a strip of fabric with selffastening tape. In the middle is piece of navy blue woven fabric. Two reflective bands the same as those on the sleeves run around the upper body, and at the back they are joined by two vertical bands. TROUSERS: Comprising front and rear pieces: The two front pieces are each made of a single piece of fabric joined to the backs at the side seams and to each other at the crotch. The fly closes with a plastic zip with metal pull covered by a flap sewn to the left-hand side and fastening with a strip of self-fastening tape across the right. A cargo pocket is attached at the outside-leg side seam either side at the thigh, which closes with a flap fastened by a piece of self-fastening tape. The top of the trousers has four belt loops arranged one either side at the front and back, fastening with self-fastening tape, and either side is a strip of fabric with a plastic toggle. The knees are reinforced in black fabric and below this are two reflective bands of the same type as that applied to the jacket. The inner trouser bottom hems are reinforced with fabric and the trousers are lined with black laminated fabric. The two rear pieces are each made of three pieces of fabric joined by horizontal seams, and joined to each other at the crotch and to the front pieces at the inside and outside-leg seams. A garment size label is attached inside at the top on the centre seam and below this is an opening with a zip and two garment conformity labels are attached inside. The trousers end in an interior backstitched hem.

The materials that form the PPE, are described in the test technical report n^o 2015EP2935CE.



It shall be the manufacturer's sole responsibility to furnish specific information pertaining to this certificate and the tested levels of protection.

PPE's CAT. III shall be submitted to control tests according to the Art. 11 of the Directive 89/686/EEC.
